Per the Ohio Department of Health the following requirements will be observed on all abatement projects;

**Item 1:** All EDG laborers working on this project are licensed or certified by the Ohio Department of Health.

- **Item 2:** For asbestos abatement, all project clearance levels and sampling will be obtained in accordance with one of the following requirements:
  - a. All clearance air sampling to be analyzed by phase contrast microscopy (PCM) will be conducted in accordance with the National Institute of Occupational Safety and Health (NIOSH) Method 7400 entitled "Fibers" published in the NIOSH manual of analytical methods, third edition, second supplement, August 1987. A minimum of three samples will be taken and show that the concentration of fibers for each sample is less than or equal to a limit of quanitation for PCM (0.01 fibers per cubic centimeter of air): or
  - All clearance air sampling to be analyzed by Transmission Electron Microscopy (TEM) will be conducted in accordance with the regulations established by the United States Environmental Protection Agency, 40 CFR Part 763, Subpart E, Appendix A: and
- Item 3: All clearance air sampling will be conducted by an asbestos hazard abatement air monitoring technician, or asbestos hazard evaluation specialist certified by the Ohio Department of Health or Certified Industrial Hygienist (CIH) or Industrial Hygienist in training as certified by the American Board of Industrial Hygiene.
- Item 4: A detailed description of the project work scope, including the amount, indicated in linear or square feet of asbestos containing materials to be abated, the exact location and type of the material, and whether or not a contained work site will be established as required by regulations of the United States Occupational Safety and Health Administration, 29 CFR Part 1926.1101.
- **Item 5:** A requirement that all asbestos hazard abatement activities be done in accordance with all applicable federal, state, and local asbestos regulations.
